She was later led by Susan Grocott KC in both the Court of Appeal and the Supreme Court in the case now known as *Re S-B* UKSC17 [2010] 1 FLR 1161. She has also been led in High Court care proceedings involving the suspicious death of a child.

Alongside her public law work, Sasha also undertakes complex private law cases involving sexual abuse, implacable hostility and international relocation.
