Practice Area: Family

Miss Gregg represented the subject child in proceedings which initially clarified the lawful mechanism for the placement of English children in secure accommodation in Scotland, leading to a change in the legislation within both jurisdictions. The case gained significant national attention upon publication of The President's third judgment in August 2017. The President of the Family Division noting that if the State was unable to provide X with the support and safe placement she required, we would have 'blood on our hands'.

Practice Area: Family

Miss Gregg represented the children's guardian in long running private law proceedings arising out of the father's application for shared residence.

The orders proposed by the children's guardian were described by the Court as being at the most extreme end of the spectrum of the Children Act orders. Those orders included a Prohibitive Steps Order limiting the father's exercise of his parental responsibility to prevent him from tracing the children, a Specific Issue Order was made to permit the mother to change the children's surname, a Family Assistance Order was made to enable the guardian to assist in the provision of indirect contact. Finally a section 91(14) order was made for a period of five years to protect the children from exposure to indiscriminate applications.
