Profile

Mr D.S. -V- G T TRADING (ELECTRICAL) LTD

Practice Area: Personal Injury

Instructed by Keoghs and AXA UK James Hogg successfully defended a sizeable claim for personal injury and loss of earnings, obtaining a finding of fundamental dishonesty following a two day multi track trial. Investigations had uncovered inconsistencies and misleading evidence from a claimant who had been made redundant prior to bringing his claim.

At trial the judge found that the accident didn't happen and the claimant knew his version of events was false. The claim was dismissed for a total saving of £116,000 with permission for the defendant to enforce their costs on an indemnity basis
